BGCNR SUNSCREEN POLICY

1. **We do not provide sunscreen for campers as** it is a medication and some campers may have allergies to some ingredients in certain sunscreens. **We also do not apply sunscreen on the campers.** Each camper needs to bring his or her own. If a camper does not have their own sunscreens please indicate below if they are still allowed to participate in outside activities.

2. Campers should arrive at programs with a thick base coat of sunscreen already applied, especially in hard to reach areas, such as their backs or sensitive areas, such as their face. This is especially important for trips and pool days.

3. We encourage campers to wear hats to protect their heads and shirts to protect their backs. This is especially important if your child has sun sensitivities.
